**STALLION BREEDING CONTRACT  
SHIPPED/PICKED UP SEMEN**

1. The 2020 breeding fee is \$1500.00 part of which is a nonrefundable Booking Fee of \$300.00. The booking fee is due with this contract and the full breeding fee is due in advance. Multiple mare discounts are available upon request.
2. Mare Owner agrees to pay a Collection Fee of \$250.00 for each second and additional shipments. Semen will be collected, shipped and/or picked up at at the designated Veterinarian .The mare owner must notify the Stallion Owner of the expected breeding date at least 2 weeks prior to the actual shipping or pickup date.
3. Charges for shipping containers supplied to the mare owner of each shipment of fresh semen will be provided by the designated Veterinarian and fees for such to be paid directly to them. Actual cost of shipment of semen with container, including the return of the container will be the Mare Owners expense.
4. Mare Owner is responsible for arranging for the diligent insemination of the mare. Insemination must be administered by a licensed veterinarian or authorized technician. Shipped semen must be used only for the mare stated on this contract.
5. Mare Owner is responsible for the pregnancy checking of the mare. If for any reason the mare does not settle, the mare owner will hold the Stallion owner and manager blameless.
6. The Mare Owner agrees to comply with the following: 1) Consult Stallion manager as to their days of collection. 2) Notify Stallion manager when the mare comes into heat. 3) Notify Stallion manager 48 hours before the anticipated time of ovulation. 4) Confirm order for semen before 10:00am (CST) **prior** to the day of shipment. Late orders may be denied shipment, or be subject to extra charges. You may cancel the pick up or shipment up until 7 a.m. (CST) on the day of shipment without penalty. Please note that Fresh semen shipments are limited due to availability of stallion during show seasons. It is advised that you consult with Eastridge Farms prior to submitting this contract for availability of fresh semen.

7. The mare shall be in a healthy and sound breeding condition. The breeding fee is for one pregnancy only.
8. MG Partners is not responsible for the untimely delivery or condition of the fresh shipped semen as we have no control of the shipment after it leaves the custody of Eastridge Farms or their agent. The Purchaser also understands the accepted protocol for handling and storage of fresh semen must be used.
9. If the stallion dies or becomes unfit for service prior to fulfilling this contract, this contract will be null and void, and the Mare Owner's breeding fee will be refunded.
10. Stallion Owner will issue certificate when notification of a live foal, providing all fees have been paid in full.
11. This contract is non-assignable and non-transferable.
12. This Contract represents the entire agreement between parties, No other agreements or promises, verbal, or implied are included unless specifically stated in this written contract.
13. This contract contains a 2 year limited "In Foal Guarantee" If by the end of the 2020 Breeding Season the Mare has not become and remained pregnant as shown by ultrasound results Certified by a Veterinarian the purchased will be entitled to the next breeding season only. The \$250.00 collection fee will apply on all and any rebreeds.

Please sign, enclose appropriate fees and photocopy of your mare's papers and return all pages of this contract. A signed copy will be returned to you. Please print clearly.
